OFFICE MEMORANDUM

Subject: Fixation of Ceiling Price of I.V. Fluids under Revised Schedule-I (NLEM 2022) of DPCO, 2013 notified vide S.O. No. 5249(E) dated 11.11.2022.

With reference to the Office Memorandum dated 01.02.2023, issued by this office on the above subject, the PTR and MAT values were requested for the month of July, 2022. However, in line with the decision taken by the Authority in its 120th meeting held on 24.01.2024, all the concerned manufacturers / marketing companies are hereby requested to furnish data in respect of Price to Retailer (PTR) and Moving Annual Turnover (MAT) in value terms for the month of **October, 2023** in the format given in **Table 1** along with the Form II/ Form V as well as licenses showing clearly the pack size, type of packaging, etc. The information may be furnished positively within 10 days from the issue of this O.M. in respect of formulations mentioned in **Table 2** for enabling NPPA to take appropriate action based on the available data. The companies are also requested to send the sample of their products to NPPA for the purpose of verification.
